1.0 THE AGREEMENT

 This Agreement between BHILAI INSTITUTE OF TECHNOLOGY, Durg, G.E. Road, Bhilai House, Durg – 49100 (C.G.) (hereinafter called FIRST PARTY),

and

1.2 ADV METAL COMBINE PVT. LTD., Shed-25 BIGC Rasmada Durg Chhattisgarh 491001 registered in India under the Company's Act 1956 (hereinafter called the SECOND PARTY).

2.0 PREAMBLE

- 2.4 It has been mutually agreed that both parties will jointly conduct awareness programs and sensitization programs on Safe E-waste disposal.
